Enrollment Services

We have Navigators and Certified Application Counselors located throughout ALL Morris Heights Health Center locations, including our School based programs. They are trained to assist you Medicaid and Child Health Plus applications and renewals ALL year round. During "Open Enrollment", they can assist you in applying for low cost quality health insurance, also known as a QHP. We service people between the ages of 0-64, regardless of income. In the case of pregnant women and children under 19 years old, immigrant status is not taken into consideration.

What you need to bring to our office:

Proof of Identity – State or city issued Identification, US or country of origin passport, permanent residency card, school issued identification.

Proof of NYS residency – State or City issued identification, utility bill or lease will suffice.

Valid Social Security Card

Proof of Citizenship or Immigration Status:

(not applicable to minors under 19 and pregnant women)

US-issued passport, Certificate of Naturalization, residency card, valid issued USCIS permit.

Proof of Income:

Last 2 pay stubs if paid every two weeks Last 4 pay stubs if paid weekly Tax return of the previous year Letter from employer NYS unemployment benefits Social Security award letter for all forms of Social Security Benefits.

Dates and Terminology to Remember

Affordable Care Act (ACA) - Also referred to as "Obama Care" law that was sign by President Obama in 2010 was created to "expand the affordability, quality and availability of private and public insurance through consumer protections, regulations, subsidies, taxes, insurance exchanges, and other reforms" (Obamacarefacts).

Market Place – is the term used for the online application system. For New York its https:// nystateofhealth.ny.gov/

QHP-Qualified Health Plans can be purchased at low cost on the marketplace.

November 15 – First day of open enrollment. You can renew your existing QHP, Change your existing coverage or apply for the first time.

Tax penalty – \$95 per uninsured adult and \$47.50 per uninsured child for 2014 or 1% of your household income up to \$285 for 2014. \$325 per uninsured adult and \$162 per uninsured child 2015 or 2% of household income. By 2016 the tax penalty will be 2.5% of taxable income.

Tax Reconciliation – the Tax penalty will be taken out of your expected tax refund for the year. Open enrollment- the time period where you can enroll into a plan. November 15 - February 15.
